This office will make every effort to issue a permit as soon as possible. Please help the inspectors by making sure the property in questions is accessible. Also, make sure the flags are located at the entrance to the property and at the proposed septic location. If this office attempts to perform the site evaluation and the property is not accessible or the flags are not out, a \$50.00 re-inspection fee will need to be paid before the work can be completed. Please help us serve you as efficiently as possible. Thank you for your patience.

A \$50.00 re-inspection fee may be charged for multiple site visits. This may include:

1. Lot was not accessible or flags were not out.
2. Inaccurate directions.
3. Inaccessible due to locked access, heavily wooded lots, marking of incorrect lot.
4. If home, well, or waterlines are not installed at time of construction approval for septic System (final approval not given).

Due to recent changes in the Florida Administrative Code 64E-6, the Department of Health's procedures for determining the mean annual flood line has changed. Field verification of the mean annual flood line can be conducted by a Certified Professional Surveyor and Mapper with experience in the determination of flood water elevation lines, or, at the option of the applicant, by department personnel.

_____ **Option 1:** I would like for the Gulf County Environmental Health Office to determine the mean annual flood line.

_____ **Option 2:** I will get a Certified Professional Surveyor and Mapper with experience in the determination of flood water elevation lines to determine the mean annual flood line. I understand that my septic application will be put on hold until the Gulf County Environmental Health Office receives this information from the Professional Surveyor and Mapper.
